

# CCV Business A.S. to Vermont State University (VTSU) Business Administration B.S.

Catalog Year: 2025-26

This transfer pathway will help you plan courses at the Community College of Vermont (CCV) that meet course specific requirements at VTSU.

- CCV and VTSU are both a part of the Vermont State College System (VSCS). Students have one common VSCS transcript. As such, courses taken at CCV are not considered transfer credit.
